The Police Commissioner answered previously submitted questions. It was confirmed that the P.C.'s point of contact should be PCSO Supervisor Chris Bannister who had already contacted the Clerk & Neighbourhood Watch.

There was concern from Members regarding drug activity within the parish which had been ongoing for sometime. The Police Commissioner urged that residents should report drug related crime via the non-emergency number 101 unless life or property are in immediate danger then 999 should be used. Police recruitment was ongoing but there had been a delay. Eventually it is hoped that Kilburn would have its own dedicated PCSO.

Further discussion took place with regard to the Speedwatch volunteer programme and the request for more police support.

The County Councillor was asked to purse DCC regarding the clean up of Bywell Lane after recent tree felling. Further work would need to be done next spring and the Clerk will remind The County Councillor.

It was reported that a resident had a problem with the heating in a Futures Home property.

The Borough Councillor to pursue AVBC with regard to the condition of the Fairview Close Play area.
