# MINUTES OF KILBURN PARISH COUNCIL MEETING HELD AT 7PM ON MONDAY 9<sup>th</sup> October 2023 IN THE VILLAGE HALL

#### 72/23 **Public Participation**

The majority of residents present had attended to voice their objection to PA AVA/2023/0493 – the change of use to the Methodist Church, Chapel St.

The objections related to insufficient access; insufficient area for amenities (wheelie bins etc.); fire regulations & 2 years of disruption caused by building work. The Borough Councilor had lodged an objection. Residents were advised to lodge independent objections.

A resident had attended a meeting with regard to Land North of Denby. He had been dissatisfied with responses given by the Borough Councillor and was in process of submitting letters which he will copy the PC.

The police gave the recent crime statistics and an explanation.

The police were asked about the law regarding bonfires in gardens. It appeared this came under anti social behaviour. This can be logged onto the police web site & also complaint sent to Environmental Health.

There had been some damage caused by motor bikes at Cinderhill near tar pits – the land owner was aware.

#### 75/23 Report of the Clerk

- a) Planning Application AVA/2023/0493 Methodist Church, Chapel St
   It was resolved to lodge an objection from the PC. Resolved that objection to include lack of access especially with the size of the property and number of inhabitants. The capacity does not suit local amenities, fire regulations & traffic.

Cllr Bailey gave an update. Speedwatch had taken place on Ryknield Rd with a number of drivers receiving letters with regard to speeding. However, there had been some abuse and the police will be asked to attend the next time they are at this location.

A meeting had taken place with interested parties. Although not ideal a conclusion had been reached that the footpath be turned into a bridle way. Hedge would be cut back, a disabled gate erected and wooden blocks which horses could go over but would prevent motorbikes using. All work would be carried out by the land owner. Resolved that residents near to footpath would receive notification from the PC as to what has been agreed.

## 81/23 Planning

- AVA/2023/0688 22A Northfield Construction of No.2 detached single storey dwellings
- AVA/2023/0493 Methodist Church Chapel St. Proposed change of use to 13 No apartments with associated infrastructure

Objection made as follows:

Parking along Chapel St is already above capacity. The addition of 13 vehicles or more will add to the situation. It cannot be assumed that residents to the 13 flats will have ebikes/bikes rather than cars.

Buses and delivery vehicles already have difficulty in accessing Chapel St with cars parking along one side of the road with very little space to allow vehicles to pass.

13 flats will mean approx 26 additional bins - there is no space on Chapel St to put these out for collection.

Fire regulations would also be difficult to enforce - especially as it would be almost impossible for emergency vehicles to access the property.

At a recent Parish Council meeting 32 residents attended in order to voice their objections. There is serious unrest amongst local residents who are opposed to this planning application.

The following planning applications have been granted

AVA/2022/0634 – Land east of Rawson Green – construction of equestrian menage & erection of general purpose agricultural building

## The following planning application has been returned

- AVA/2023/0092 - 5 Bottle Brook - Temporary siting of storage container for a period of 3 years

The following planning applications have been refused – It had been noted that on AVBC Planning web site PA AVA/2023/0554 – White Barn 15 Horsley Rd had been refused.

#### **Tree Preservation**

- AVBC have made an application to put a tree preservation order on Trees & woodland to the north of Derby – TPO488/2023 – A planning application AVA/2023/0182 was received which included an arboriculture report. The report identified large areas of woodland that would require removal along with individual veteran trees and important habitat. If work takes place on the site that does not require planning permission, in preparation for any other work on the site, damage could be caused to these important trees.
