Neighborhood Watch Update



The team at Kilburn & Denby Neighbourhood Watch hope that you have been keeping safe and well during the recent lockdown in response to the coronavirus pandemic.

With many more of us working from home, inevitably crime is on the increase and unfortunately in our local area we have seen a number of thefts and incidents crop up. 3 incidents of note would be the trying of property doors on Mayfield Avenue, the theft of a catalytic converter in Horsley Woodhouse and the theft of a caravan in Denby.

It is of vital importance that residents remain vigilant and make good use of the police 101 telephone number (which is now free!!) to report non-emergency incidents and also the use of the 999 number if a crime is currently in progress, a suspicious incident is taking place or life is in danger.

We have also provided some basic crime prevention advice below to protect you and your property from these recent types of crime:

Catalytic convertor crime

- 1. Park to prevent access underneath your vehicle.
- 2. Mark catalytic convertors with a serial number.
- 3. Ask a garage to weld the bolts shut.
- 4. Invest in CCTV cameras
- 5. Park in well-lit areas
- 6. Install a car alarm

Caravan theft

- 1. When parked or not in use lock the caravan in several ways using devices such as a hitchlock, locking wheel nuts, a wheel clamp, a wheel lock and steady locks. Visit the Sold Secure website for more information about caravan security devices. If using chains, ensure they are very heavy duty go to the Sold Secure site
- 2. Do consider fitting a tracking device.
- 3. Fit an alarm and use it whenever the caravan is vacated.
- 4. Consider installing a caravan safe.
- 5. Consider hiding several identifying RFID electronic tags around the caravan in case a thief removes the visible vehicle identification numbers (VINs). Most caravans will already be installed with RFID tags under the CRiS scheme.
- 6. Windows, doors and rooflights should be closed and locked whenever the caravan is vacated. Consider supplementing any manufacturer's fitted locks with additional locks if appropriate.
- 7. Do not leave paperwork relating to the caravan inside the caravan, such as the CRiS registration form as this can help a thief to sell it on
- 8. Keep your caravan keys separate from the car keys and keep them on your person or when at home put them in an insurance rated safe.
- 9. Photographs of the interior and of identifying marks may be useful for later identification.
- 10. Ensure your CRiS registration details are kept up-to-date.
- 11. Make a note of serial numbers of equipment kept on-board.

Following a request from the Parish Council and the Borough Council – Derbyshire County Council have undertaken repairs to the footpath which leads from Elm Tree Avenue to Woodhouse Road - residents will find that this footpath is now accessible and has been tarmacked to KILBURN PARISH hopefully stop flooding for the future.

An 'Honour Board' will soon be erected outside the Village Hall. The 'Honour Board' will recognise the achievements of parishioners both past and present of service to Kilburn.

Fairview Play Area – the Parish Council is still pursuing with the Borough Council in turning this area (which has been decommissioned as a play area) into a community garden. The Borough Council are investigating the legalities. Once that has been completed, the Parish Council will be coming out to residents to discuss how this can be best facilitated with a working party setup. We would ask all residents to engage with what could be an excellent item for the community.

The Parish Council has been successful in obtaining a Grant of £15000 towards the upgrading of the nature reserve at Rawson Green. The fundamentals of this work are to make the nature reserve more accessible for anybody from within the village or surrounding areas.

A tender for the work has been accepted. A tree survey is soon to take place before work can commence as the reserve is overcrowded and has some diseased/badly damaged trees within it.

The Council has marked many memorial trees which will be preserved, however, if anybody knows of persons outside of Kilburn who have planted a memorial tree could they ask that they contact the Parish Council Clerk as soon as possible.

The Council would like to thank those residents and Members of the Council who have individually undertaken litter picking throughout the village – it is much appreciated. Litter appears to be a problem not only in Kilburn but nationwide. Please could we ask everybody to take their litter home and not drop for others to pick up. There has been a large influx of paper masks which are also being dropped, please take care as these are a cause of concern for Health & Safety and Wildlife.

A Community Litter pick is to be arranged for **SATURDAY 26TH JUNE** when it is hoped the current Covid restrictions will be lifted. Further details of this will be available on the noticeboards and the Parish Council website in due course.

Could we also ask dog owners to clear up after their dogs and use the bins provided or take home. Increasingly dog waste bags are being dropped either on the floor or being thrown into hedges.

Speed signs have now been installed in the village to hopefully make drivers aware of the speed limits within the area. We know that this will not stop everybody but a number of residents have already commented on the success of the signs.

The next edition of the Kilburn News will be delivered out to residents via our employed delivery person. There was a small hiatus while the Risk Assessment and Health & Safety of volunteers was reviewed. We thank all volunteers who have been delivering on our behalf and when safe to do so, they will be back to delivering for us around the village. Look out for the holders which are also now installed on the notice boards where editions of the Kilburn News will be put, if you do not get one at home.

The planters will be being installed over the coming months, all of the testing of the lampposts has been completed and the colour will be returning for another successful year like last year's display.

At the March meeting – the Council discussed the return of 'face to face' meetings. Currently, the law allows for remote meetings to be held until 7th May, however, this may be extended. The Council will make a decision with regard to the May meeting (due to be held on Monday 10th May) at the April meeting. In the meantime, parishioners are reminded that if they wish to attend a remote meeting they should contact the Clerk on Kilburnparishcouncil@gmail.com.

The Annual Parish meeting will take place remotely prior to the April meeting at 7pm on Monday 12th April. At this meeting a report is given by the Chairman of the Council's activities for the past year and Parishioners are able to ask questions.

Again, as above, please contact the Clerk if you wish to attend.

Many complaints have been received with regard to the gas works taking place on Ryknield Road. These complaints have been reinforced by the Parish Council and sent to Cadent the contractor concerned

Councillor Kevin Buttery – Keeping you updated.

Despite no longer owning or having any responsibility for Greenwich Park at Ripley, AVBC has agreed to pay £5,000 towards a Feasibility Study for the owners, Ripley Town Council. I have objected to this and requested that this decision is scrutinised.

AVBC now publishes daily on the home page of the Councils website, the streets it has missed for waste and recycling collection. Recent published figures state the cost of delivering the service this financial year has increased by another £500,000, making next year's cost £4.1 million. It cost £2.6m in 2019.

According to the Local Plan timetable, the sites to be included in the Plan should have been determined in March and sent out for public consultation in April. No sign yet. I welcome the recent Government changes, in which Amber Valley no longer has to take any of the 2,375 houses on behalf of Derby City. The City are now legally responsible for their own housing need, albeit the Council still has a duty to cooperate.

Based on the fact that Amber Valley only has to find sites to deliver 7,125 homes and apparently has a 5year housing supply, I have requested that Cinderhill and other sites locally, should be taken out of the Local Plan. I also requested that all Greenbelt sites be removed from the Council's 'call for sites' list.

The Electoral Commission has determined that the number of elected members at AVBC should be reduced from 45 to 42. Consultation will be undertaken in respect of the shape of Wards, which I expect to follow existing parish boundaries. If you wish to have your say on where you think the Ward boundaries should be, visit www.consultation.lgbce.org.uk The Consultation closes on 3rd May.

Derbyshire County Council has agreed to spend £120m on the county's roads over the next 3 years. The investment will be aimed at resurfacing roads and pavements, improvements to drains and 46 road safety schemes.

The work will be undertaken by DCC staff, specialist contractors and will involve recruitment of an additional team of workers.

Across Derbyshire, there has been 59,000 residents and non-residents, who have undertaken

Covid-19 community testing, in which 587 people who showed no symptoms, tested positive. Regular testing does help in reducing the spread of the virus. In respect of Amber Valley, 10,071 took the test with 119 people being found positive.

As of 7th March, in Derby & Derbyshire, 376,951 people have been vaccinated with the first dose, which places us third highest in the Midlands and is a tremendous achievement by all those involved in its delivery.

I am pleased that Kilburn Youth Football Club was awarded two Action Grants totalling £3,514.

I am also pleased to support Horsley Woodhouse Carnival Association community clean up events in line with the 'Keep Britain Tidy' campaign, with a £300 grant from my Community Leadership Fund. Litter and Fly-tipping cost councils millions of pounds nationally, so it is brilliant to see residents taking pride in their community and working together to help to keep everywhere clean and tidy.

Over the last year during lockdown we have seen more and more people out and about in the much-needed exercise time each household gets to help their mental health and interact with others.

With more people outside within our village more and more litter is appearing on the streets making its appearance look unkempt. We would ask that while you are out during your walks, if you could pick up any litter and help in keeping our village tidy, we would really appreciate it.

A number of villagers early on last month walked a large portion of the village and collected 12 bags within an hour.

Our Parish Council leaders also collected 6 bags along Bywell Lane, this is in addition to all that the locally employed Parish Warden does.

However, we need to do more, this is our plea. Please can you all help in making our village a cleaner and tidier place for all to be proud of.

A community litter pick will be arranged Saturday 26th June, when restrictions allow.

This will have the support of our local Borough & County Councillor, Trevor Ainsworth who will be with us on the day assisting with the PPE required and collecting litter with us.

Speeding

You will now all have seen the speed signs which have been positioned strategically across the village on all of the major roads.

The signs were created by winners from a competition ran within the Junior School and a winner from each class was selected. The Parish Council then funded the purchasing of 70 of the signs to be used for display.

We are hoping with the signs now in place, they create a reminder for all people travelling through the village that 30mph is the speed limit.

We are aware that this will not stop all speeding and will be canvassing law enforcement and providing our support to the Neighbourhood watch speed awareness team to hopefully assist us in slowing people down through the village.

Arthur Medical Centre is committed to the success of the Covid-19 vaccination programme and is working with local partner practices to deliver an effective, centralised service via Babington Hospital. The programme has been highly successful thus far and we have recently received a very positive letter from the Health Secretary, Rt. Hon. Matt Hancock, received via Pauline Latham MP, recognising that the provision via our Babington Hub is one of the best in England in terms of efficiency and performance.

We are working to provide vaccinations to patients in order of priority, in strict accordance with government guidance. Please be assured that we will contact patients when we are able to offer a first vaccination by telephone or SMS message.

We are also now inviting patients for their second Covid jabs, in the same priority group order as the first wave of vaccinations when we began in January 2021.

Again, we will contact you by telephone or SMS message as soon as we are able to invite you for your second Covid jab.

We are only able to help you with enquiries regarding vaccination bookings for our Babington Hospital hub. If you have a query regarding a vaccination that is not organised via our Babington hub, we will not be able to assist you with this and you should contact NHS by calling 119.

This Practice is open, as it has been throughout the pandemic, however a restricted service is currently provided to allow us to support the mass vaccination of our community.

We continue to offer telephone assessments for all requests to see a GP or Advanced Clinical Practitioner and you will be offered a face to face appointment at the surgery, if the clinician feels you need one.

What you can do to help

Please help us by being considerate with your requests - and your expectations - when communicating with our reception and clinical staff. Please consider how urgent or significant your query or request is before contacting the surgery.

We want to reassure you that patient care is our absolute priority. You should still contact us if you have an urgent or pressing need and we will still do our best to help you when you need our services. However, many non-urgent matters or queries may be able to wait until this critical period is over, or may be best referred to another solution such as a centrally managed service or a community pharmacy.

Covid-19 Update

Please find a brief timeline of this Government Covid-19 road map below,.

- From March 29th, outdoor gatherings (including in private gardens) or either 6 people (the Rule of 6) or 2 households will be allowed.
- Although the "stay at home" rule will end on 29th March, people are advised to still
 work from home where they can and minimise the number of journeys they make
 where possible.
- From the 12th of April, non-essential shops, beauty salons and public buildings will open. Indoor leisure facilities such as gyms will also reopen (but only for use by people on their own or in household groups).
 - Outdoor attractions and settings including hospitality venues, zoos and theme parks will also open. Self-contained accommodation such as campsites and holiday lets can also reopen.
- Hospitality venues will also be allowed to serve people outdoors from the 12th of April.
- From the 17th of May, legal restrictions on meeting others outdoors will be lifted, however indoors the Rule of 6 or 2 households will still apply.
- Most businesses in all sectors will be able to reopen, including indoor hospitality.

We would like to thank the members of our community who have continued to adhere to the Government guidelines and ask that you continue to do so. Please use the Government website to keep up to date with the guidelines, as they are subject to change at any time.


